



2015 \$1,000 Scholarship Award Program

The following guidelines must be followed in order for your application to be considered for this scholarship:

1. All scholarship applicants must use the current 2015 ASFCU Scholarship Application Form in order to be considered for the scholarship. All items on the application form must be completed.
2. All scholarship recipients must be a member of ASFCU or have an immediate family member that belongs to ASFCU. Recipients must be a current high school senior graduating from one of the following counties: Ashley, Bradley, Chicot, Cleveland, Desha, Drew and Lincoln. Student must be enrolled in a college or university, full-time, before receiving scholarship funds. Employees and Board of Directors of ASFCU and their children and grandchildren are not eligible for the scholarship.
3. Two letters of reference are required, one should be personal (not from a family member) and one should be of an academic nature (school administration, faculty, teacher).
4. Have the school registrar or counselor sign and affix official school seal on the application form in the appropriate place.
5. The scholarship application and letters of recommendation must be postmarked on or before **April 27, 2015** and mailed to the following address:

Selection Process:

All decisions will be based on both subjective criteria and weighted, objective criteria. These include academic performance, essay, community activities and personal goals. Each application will be evaluated by an outside agency to provide an unbiased decision. Once the scholarship recipient is chosen, the funds will be awarded to the applicant upon receiving a receipt showing that the school tuition has been paid.
